### **APPLICATION**

- An application form for certification identifying the position.

### **INSTRUCTION (If Applicable)**

- Copy of the score letter(s) or certificate(s) for each of the required accredited CSFM courses.
- Copy of the completion certificate(s) for any additional training that is required.

### **PREREQUISITE (If Applicable)**

- Copy of position certificate or verification of rank signed by the Fire Chief and written on department letterhead.  
Or
- Copy of college transcripts.  
Or
- Copy of certificate for each of the required courses.

### **EXPERIENCE (If Applicable)**

- Verification of the experience requirement in the form of a letter signed by the Fire Chief and written on department letterhead.
